Ken Paxton Shows Major East Texas Momentum, Announces Over 220 Tyler/Smith County Endorsements

Stellar list includes all three GOP Smith County Commissioners, Ted Cruz Leadership, SREC Members, Republican Activists, and Prominent Business, Community Leaders

(McKinney, Texas) - Senator Ken Paxton, Republican candidate for Attorney General, demonstrated strong East Texas support today as he released a list of more than 220 Smith County business and community leaders, Republican activists, and current and former elected officials endorsing his candidacy. The list includes all three Smith County Republican County commissioners, Former Tyler Mayor Joey Seeber, Former State Representative Leo Berman, both State Republican Executive Committee (SREC) members who represent Smith County, and numerous GOP precinct chairs (see list at end of release). Senator Paxton has previously been endorsed by State Representatives Matt Schaefer and Bryan Hughes, both of whom represent Smith County.

Paxton stated, "From the start of our campaign and winning the very first straw poll here in East Texas, we have worked hard to earn the trust and support of Smith County conservatives. Today, I'm honored and humbled by this outpouring of support from one of the most important counties in the state. As Attorney General, East Texans can count on me to fight the encroachment of the Obama administration, defend the strongest pro-life bill in the nation, support efforts to secure our border, stand firm for traditional marriage, and uphold our voter ID laws."

On the day that Senator Paxton is visiting East Texas cities including Texarkana, Marshall, and Longview, local Smith County conservatives articulated their reasons for endorsing the McKinney Republican.

Retired District Judge and local attorney Cynthia Stevens Kent stated, "Ken Paxton is a conservative Texan, experienced attorney, businessman, family man and respected State Senator, who will bring his common sense and experienced voice on legal issues to the office of Texas Attorney General. From the more than 20 years I served as a judge in East Texas, my 36 years as a licensed attorney, a lifetime supporting conservative Republican policies and my knowledge of Ken Paxton, I know that Texas needs Ken as our top lawyer. Ken will bring to the Texas Attorney General's position his boots on the ground experience in understanding, writing and fair enforcement of our laws so that Texas families have a safer and healthier life enjoying the freedoms guaranteed by our Constitution."

Senator Ted Cruz Statewide Finance Committee member and Kitchen Cabinet member Resa Clarke, who recently chaired Senator Cruz's Smith County fundraiser, said, "It's exciting to support a candidate like Ken Paxton for what has recently become one of the most important offices in the State of Texas. The Attorney General must be an ethical defender of state's rights and act expeditiously for the citizens of this great state. Ken Paxton is the only candidate that has a proven record of doing what he says he will, making him the most qualified to be our next Attorney General. It was an honor and privilege to help elect Ted Cruz to the U.S. Senate, and I am now excited to help elect Ken Paxton as Texas' next Attorney General."

David O. Dykes, Pastor of Green Acres Baptist Church* said, "Ken Paxton is a proven conservative who embraces Biblical morality. He is a man of conviction and Christian character who will defend conservative values for Texas in the Attorney General's office. Stephen Dement is a respected local attorney, small businessman, and educator who founded a local Christian college preparatory school. In his endorsement of Paxton, he said, "I am impressed with the character, qualifications, and conservative credentials of Senator Ken Paxton. As our next Attorney General, I am confident in his ability and commitment to stand for East Texas values of faith and family."

Additionally, Senator Paxton has won all six straw polls conducted in the campaign so far.
